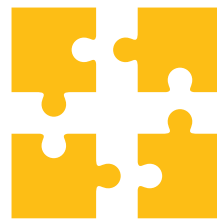
REPORT SUMMARY

The ongoing pandemic has indeed destabilised the normal ways of global functioning. In the case of Tirupur and the garment factories here, circumstances were dire owing to the loss of jobs, lockdowns continuing over months and people having issues in access to relief and support.

The staff and volunteers of SAVE showed an extensive understanding of their **responsibility** towards the organisation's objectives and in particular to the current demands. Their **resilience** helped in quickly plan and execute multiple new initiatives, pooling in all **resources** at our ends to offer extensive support and **relief** to people in distress, while continuing to engage with planned project activities.

86 in-house staff and 1272 volunteers played their role dutifully in their respective positions, and beautifully supported vulnerable people overcome the undue circumstances. A short summary of impact created follows.

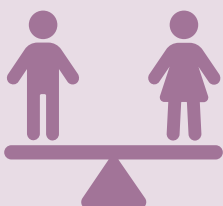

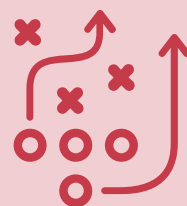

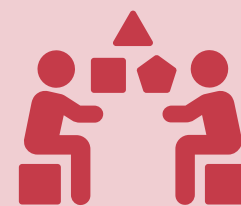
